## CEFLEX initiative: Extended Producer Responsibility supports circular economy solutions for flexible packaging

**Brussels, 25 January 2018.** Under the CEFLEX initiative, the Extended Producer Responsibility Alliance (EXPRA) is committed to increasing the collection and recycling of flexible packaging formats below A4 in size. CEFLEX's ambitions are to make flexible packaging more relevant to the circular economy by advancing better system design solutions via stakeholder collaboration representing the entire value chain, by 2025.

Since CEFLEX's official launch in 2017, the number of participating stakeholders has risen by 56%, to reach 53, with companies and organisations from across the value chain. EXPRA has supported the initiative since its creation.

The project is particularly focused on consumer flexible packaging formats. Being either single or multi-layer, these use a variety of materials and are not widely collected today for recycling in Europe.

The stakeholders involved also work on the development of the first phase of Design for a Circular Economy Guidelines for flexible packaging. A public consultation on the draft guidelines will be launched in spring 2018. In addition, CEFLEX stakeholders are working together to identify and promote the best technical solutions to enhance the performance of flexible packaging in a circular economy.

EXPRA's Managing Director, Joachim Quoden, commented: "CEFLEX is a unique initiative and considering that EPR is the link between all stakeholders across the value chain, we have been involved since the very beginning and strongly supported it. We are fully aligned with the objectives of the initiative and believe that, based on our vast experience of over 25 years, our 26 members could significantly contribute to achieving the initiative's goals thus helping Europe become truly circular, innovate and grow".

"Thanks to CEFLEX's broad base of stakeholders and strong collaboration, progress is being made in all seven work-streams," explained Graham Houlder, the project coordinator. He would like to see a rapid progress but recognises that this will require wide support from society in general: "Our goal is to get commitment and buy-in from the whole value chain including local authorities and regulators. This is essential to ensure the broad-based adoption and implementation of what we are developing for flexible packaging in a circular economy".
